RENTAL

(1) Lessee shall pay the following rent: For the first five (5) years, beginning May 1, 1946 and ending May 1, 1951: An annual rental of Twelve Hundred Dollars (\$1200.00) in equal monthly installments of One Hundred Dollars (\$100.00) payable on the first day of each month in advance. TITLE

(3) Lessor covenants that it is well seized of the demised premises, has good right to lease them and hereby warrants and agrees to defend the title thereto and to reimburse and hold Lessee harmless from any loss by reason of any defect in the title. Lessor agrees to notify Lessee immediately upon any default in payment of mortgage interest or principal, or in payment of taxes or other liens upon the premises and Lessee 5° all have the right to make such defaulted payments for the account of Lessor. Any sums so advanced by Lessee including costs and attorneys' fees incurred by Lessee in defending any suits and protecting its rights herein granted, shall bear interest at the rate of six per cent (6%) per annum, and the rent provided for herein may be applied to the payment of such sums and interest, or lasses may require lassor to pay any unpaid balance. Should the term of this lease or any receival term provided for herein, expire before such sums with interest have been fully repaid to Lessee. Lessee may, at its option, continue to occupy said premises on the terms and conditions herein provided until such sums with interest have been fully resoid.
