ALL that certain piece, parcel or lot of land with all improvements thereon situate, lying and being on the western side of Harness Trail, in the County of Greenville, State of South Carolina, being known and designated as Lot No. 136 on plat of property of Bharat H. Majmudar & Bharati B. Majmudar recorded in the RMC Office for Greenville County in Plat Book 7-D, page 7.
