In consideration of Six Thousand Five Hundred and no/100 (\$6,500.00) ----- Dollars  
 and assumption of mortgage indebtedness as set forth below,  
 the receipt of which is hereby acknowledged, have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release  
 unto CHRISTINA E. LLOYD, her heirs and assigns, forever:

ALL that piece, parcel or lot of land, with all buildings and improvements  
 thereon, situate, lying and being on the western side of Danwood Court, in  
 the Town of Simpsonville, Greenville County, South Carolina, being known  
 and designated as Lot No. 35 on a plat of WESTWOOD, SECTION I, made by  
 Piedmont Engineers and Architects, dated February 5, 1970, recorded in the  
 RMC Office for Greenville County, South Carolina, in Plat Book 4-F, page  
 21, reference to which plat is hereby craved for the metes and bounds  
 thereof.

The above property is the same conveyed to the Grantors by deed of Wm.  
 Goldsmith Co., recorded December 16, 1977 in Deed Book 1070 at page 269,  
 and is hereby conveyed subject to all rights of way, easements, conditions,  
 public roads and restrictive covenants reserved on plats and other  
 instruments of public record and actually existing on the ground affecting  
 said property.

The Grantee agrees and assumes to pay Greenville County and Town of  
 Simpsonville property taxes for the tax year 1979 and subsequent years.

As a part of the consideration of this deed, the Grantee agrees and assumes  
 to pay in full the indebtedness due on the note and mortgage covering the  
 above described property given to Collateral Investment Company in the  
 original sum of \$23,200.00, recorded in Mortgage Book 1418 at page 719,  
 which has a present balance due in the sum of \$22,978.04.

As a further of the consideration of this deed, the Grantors do hereby  
 assign, transfer and setover unto the Grantee all their right, title and  
 interest in and to any escrow deposits maintained by the Mortgagee in  
 connection with the mortgage loan referred to above.

together with all and singular the rights, members, blemishments and appurtenances to said premises belonging or in any wise incident or appurtenant; to have and to hold all and singular the premises before mentioned unto the grantee(s), and the grantee(s)' heirs or successors and assigns, forever. And the grantee or donee hereby bind the grantor(s) and the grantor(s)' heirs or successors, executors and administrators to warrant and forever defend all and singular said premises unto the grantee(s) and the grantee(s)' heirs or successors and assigns against the grantor(s) and the grantor(s)' heirs or successors and against every person lawfully claiming or to claim the same or any part thereof.
