Know All Men by These Presents:

The Linda Dale S. Horne *[Signature]* *[FILED]* heretofore referred to as Grantor, in consideration of the sum of Five Thousand Two Hundred Fifteen Dollars and no/100 (\$5,250.00) DOLLARS, paid to Grantor by Don Allen & Yvonne Suzette *[Signature]* *[FILED]*, heretofore referred to as Grantee, at and before the sealing of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the said Grantee, their heirs and assigns forever:

ALL those certain parcels or lots of land situate, lying and being in the State of South Carolina, County of Greenville, Oneal Township, on the Southeast side of Darby Road, being shown as containing 1.6 and 0.6 acres on a plat of property prepared for Richard D. Bishop and Margie P. Bishop by W.R. Williams, Surveyor, dated April 30, 1976, recorded in Plat Book 5-T page 67, and having the following metes and bounds;

BEGINNING at a point in center of Darby Road, corner of Coleman property and running thence with the line of Coleman, S 36-41 E 25 feet to an iron pin on edge of Road; thence continuing with the same course for a total distance of 1144.5 feet to an iron pin; thence S 58-13 W 270.6 feet to an iron pin; thence N 38-27 W 284.5 feet to an iron pin; thence N 57-06 E. 253.5 feet to an iron pin; thence N 36-41 W 845.9 feet to a point in center of Darby Road (iron pin back on line at 25 feet); thence with the center of Darby Road, N 34-21 E 26.4 feet to the point of beginning.
