the receipt of which is hereby acknowledged, have granted, bargained, sold, and released, and by these presents do grant, bargain, sell and release unto George W. Grant, Jr., his heirs and assigns, forever:

ALL that certain piece, parcel or lot of land situate, lying and being in the State of South Carolina, County of Greenville, Chick Springs Township, about one mile north of Chick Springs, lying west from the St. Mark Road, and on the south of a road now known as McConnell Road, being more particularly shown on plat entitled "Plat for Claude Phillips" prepared by Webb Surveying & Mapping Company, dated March 1979, recorded in Plat Book 12 at Page 36 of the RMC Office for Greenville County, and having according to said plat the following metes and bounds, to-wit:

BEGINNING at an iron pin on the southern side of McConnell Road at the joint corner of this property and property of Champion and running thence with the common line of said lots, S 17-56 E 329.42 feet to an i.p.o.; thence turning and running, S 65-30 W 75.35 feet to an i.p.o.; thence turning and running, N 36-43 W 351.33 feet to an i.p.s.; thence turning and running with McConnell Road, N 70-25 E 188.07 feet to the point of beginning; said tract containing 1.0 acres, more or less.

This is a portion of the same property conveyed to the Grantors by deed of Inez N. McConnell recorded February 19, 1970 in Deed Book 884 at Page 542 of the RMC Office for Greenville County.
