DURABLE POWER OF ATTORNEY

KNOW ALL MEN BY THESE PRESENTS, THAT I, FRANK L. MAXWELL, SR., a legal resident of Spartanburg County, South Carolina, do hereby constitute and appoint SARA MAXWELL BRUCE and FRANK L. MAXWELL, JR., jointly and only as joint parties, to act as my attorneys, giving and granting unto said attorneys, for me and in my name, full power and authority to do and perform all and every act and thing as fully to all intents and purposes as I might or could do if personally present including the following powers, which enumeration of specific items, rights, acts or powers is not intended to nor does it limit or restrict the general powers herein granted to said attorneys—in—fact:

- 1. To ask, demand, sue for, collect, recover and receive all sums of money, debts, dues, accounts, legacies, bequests, interest, dividends, annuities and demands of every kind now or hereafter due, owing, payable or belonging to me, and to have, use and take all lawful means in my name or otherwise for the recovery thereof by attachments, arrest, distress or otherwise; and to compromise the same, and to execute releases and discharges for the same in my name.
- 2. To bargain, contract, agree for, buy, sell, mortgage, hypothecate and in any and every way and manner deal in and with goods, merchandise, real property, choses in action, and other property, and to release mortgages on lands or chattels.
- 3. To borrow from time to time such sums of money and upon such terms and security as to my attorneys-in-fact may seem fit and proper and upon the security of any of my property, either real or personal or otherwise.
- 4. To enter any lock box or safe deposit box standing in my name with the same authority and purpose as I would have if acting personally and to remove any and all of the contents thereof.
- 5. To transact any and all banking, financial and commercial business of every nature at any and all banks, savings and loan or other saving institutions, or any financial institution in which I have accounts.
- To execute any and all papers and documents in connection with all of the powers herein granted.
- 7. I hereby specifically revoke and cancel any other Power of Attorney granted by me and I specifically revoke that Power of Attorney granted to my daughter, SARA MAXWELL BRUCE by instrument dated February 16, 1979.

I hereby ratify and confirm everything my attorney shall do or cause to be done by virtue of these presents.

This power of attorney shall remain in full force and effect until I give notice in writing that such power is terminated.

This power of attorney shall not be affected by physical disability or mental incompetence of the principal which renders the principal incapable of managing his own estate and it is executed and to be construed and interpreted as a general and "durable" power of attorney as defined under the laws of the State of South Carolina.
