	(1) The total tap fee currently due from Owner(s) to the Subdistrict for the Property is \$ 400 55			
	(2) Owner(s) agree to pay said tap fee in installments as follows: (a) \$ 10000 paid down at this time; (b) the balance of \$ 30000 to be paid in equal annual installments of \$ 10000 each, plus interest on the unpaid balance at the rate of eight (8%) percent per annum, commencing one year from this date. All accrued interest shall be due and payable annually, together with the annual principal payment.
