C., made on Oct. 5, 1961, and having the following metes and bounds: BEGINNING at a point on Lyle Dr. (formerly Plantation Rd.) and running along said road S.65-00 W. a distance of 82 ft. to a point; thence N. 22-15 W. a distance of 195.0 ft.; then N. 65-0 E. a distance of 82 ft; thence S. 22-15E. 195 ft. to the point of beginning. That Lyle Dr. is also known as Lincoln Rd.

That if default be made in the performance of any of the terms hereof, or if default be made in any payment of principal or interest, or any notes hereof or hereafter signed by the undersigned, the undersigned agrees and does hereby assign the rents and profits arising or to arise from said premises to the Bank and agrees that any judge or jurisdiction may, at chambers or otherwise, appoint a receiver of the described premises, with full authority to take possession thereof and collect the rents and profits and hold the same subject to the further order of said court.

That if default be made in the performance of any of the terms hereot, or if any of said rental or other sums be not paid to Bank when due, Bank, at its election, may declare the entire remaining unpaid principal and interest of any obligation or indebtedness then remaining unpaid to Bank to be due and payable forthwith.
