3. Hereby assign, transfer and set over to Bank, its successors and assigns, all monies now due and hereafter becoming due to the undersigned, as rental, or otherwise, and howsoever for or on account of that certain real property situated in the County of

Greenville , State of South Carolina, described as follows:

All that piece, parcel or lot of land lying, being and situate on the West side of State Highway no. 101 (Also known as the Gap Creek Road) about eight miles North of the City of Greer, in Highland Township, County and State aforesaid, and being known and designated as lot No. Four (4) of a subdivision of the Lenoah School District lot as shown on plat prepared by Terry T. Dill, Registered Engineer, dated July 1958 and which plat has been recorded in the R.M.C. Office for said County in Plat Book 00, page 152, and having the following courses and distances, to-wit; Beginning at an iron pin on the West side of said highway at the joint front corner of lots nos. 4 and 5 as shown on said plat, and running thence with the joint property line of said two lots S. 88-30 W. 150.2 feet to an iron pin on line of lot no. 3 as shown on said plat, thence with the line of lot no. 3 S. 10-30 E. 139.3 feet to an iron pin in a community road, thence along said road N. 86-15 E. 120 feet to State Highway no. 101, thence with State Highway no. 101 N. 2-15 E. 132 feet to the beginning point. 5. That Bank may and is hereby authorized and permitted to cause this instrument to be recorded at such time and in such places as Bank, in its discretion, may elect.

6. Upon payment of all indebtedness of the undersigned to lank this agreement shall be and become void and of no effect, and until then it shall apply to and bind the undersigned, their heirs, legatees, devisees, administrators, executors, successors and engine, and inure to the benefit of Bank and its successors and assigns.
