ALL that certain piece, parcel, or lot of land situate, lying and being in the State of South Carolina, County of Greenville, known and designated as the greater portion of Lot No. 13 of a subdivision known as Wood Circle as is shown on a revised plat thereof dated May 25, 1969 and recorded in the R.M.C.
