at Pages 55 through 57.

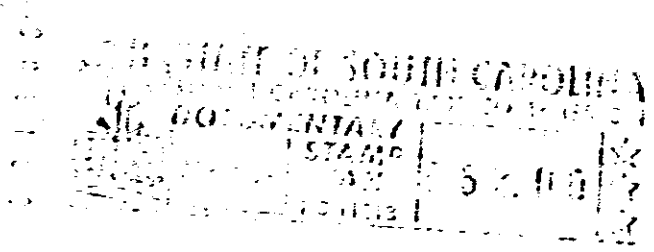
