CONTINGENCIES

In event of the death of both Optionors while this option, or the contract resulting from its exercise, is in force and effect, or after their deaths the option is exercised, the Executor (s) or Administrator (s) of either or both of their Estates, are authorized, empowered and directed to make, execute and deliver the title deed aforesaid, upon receipt of the purchase price aforesaid, and timely compliance with the terms of this option and with the terms of the contract resulting from the exercise of this option.

In event any of the Optionees, their heirs, successors or assigns, shall go into receivership or bankruptcy, either voluntarily or involuntarily, while this option or any unconsummated contract resulting from its evercise is in force and effect, then either of the optionors, their heirs or personal representatives may declare this option or said unconsummated contract terminated, and null and void.

DESCRIPTION of the LAND

The land covered by this option is situate in Austin Township, in Greenville County, State of South Carolina, containing 1.03 acres, more or less, including 90.17 acre of right-of-way in Butler Avenue, according to a plat made from a survey by Enwright Associates, Engineers, for J. T. Whatley and Minnie L. Whatley, dated May 20th, 1974, as amended September 23rd, 1974, and according to said plat, having the following metes and bounds, to wit:
