

One half of my interest in all that certain piece, parcel or lot of land with the buildings and improvements thereon situate, lying and being on the Northeast side of the Brushy Creek Road, and on the West side of the road leading to Taylors (sometimes referred to as Owens Road) in Chick Springs Township, in Greenville County, South Carolina, being shown as a portion of Lot 1 on Plat of Property of Warren Walker Estate made by W. J. Riddle, Surveyor, May 6, 1921, recorded in the R. M. C. Office for Greenville County, South Carolina, in Plat Book "L", at page 75, and having according to said plat the following metes and bounds, to-wit:

BEGINNING at a point in the center of the road leading from the Super Highway to Brush Creek (sometimes referred to as Brushy Creek Road), said point being 351.5 feet in a Northwesterly direction from the point where the center of said Brushy Creek Road intersects with the center of Owens Road, and running thence along the line of Property of Alvin A. Green N. 76-27 E. 228.5 feet to an iron pin in the center of the Owens Road; thence along the center of the Owens Road N. 1-0E. 70 feet to an iron pin, corner of lot of Sybil M. Stewart; thence along said Stewart Line in a Westerly direction 275 feet, more or less, to a point in the center of Brushy Creek Road; thence with the center of Brushy Creek Road S. 32-15 E. 76.6 feet, more or less, to the beginning corner.

This is a portion of that lot conveyed to Grantor by deed of L. W. Owens, Master, dated July 11, 1952, and recorded in the R. M. C. Office for Greenville County, S. C., in Deed Book 459, at page 70.
