The Lessee agrees that if after exhaustion of the moneys in the Construction Fund the Lessee should pay any portion of the said costs pursuant to the provisions of this Section, it shall not be entitled to any reimbursement therefor from the County or from the Mortgagees, nor shall it be entitled to any diminution of the rents payable under The obligation of the Lessee to Section 5.3 hereof. complete the Project shall survive any termination of this Agreement, subject to the force majeure provisions of the concluding paragraph of Section 10.1.

SECTION 4.7. Authorized Lessee Representative and Successors. The Lessee will designate, in the manner prescribed in Section 1.2, the Authorized Lessee Representative. In the event that any person so designated hereunder and his alternate or alternates, if any, should become unavailable or unable to take any action or make any certificate provided for or required in this Agreement, a successor shall be appointed in the same manner.

of Remedies 4.8. Enforcement SECTION Contractors and Subcontractors and Their Sureties. Lessee covenants that it will take such action and institute such proceedings as shall be necessary to cause and require all contractors and material suppliers to complete their contracts diligently in accordance with the terms of said contracts, including, without limitation, the correcting of any defective work, with all expenses incurred by Lessee in connection with the performance of its obligations under this Section 4.8 to be considered part of the costs referred to in Section 4.3(h), and the County agrees that the Lessee may, from time to time, in its own name, or in the name of the County, take such action as may be necessary or determined by Lessee, to insure the as construction of the Building in accordance with the terms of such construction contracts, and the installation of machinery and equipment in accordance with any applicable contract pertaining thereto, to insure the peaceable and quiet enjoyment of the Project, for the Lease Term, and to insure the performance by the County of all covenants and obligations of the County under this Agreement, with all costs and expenses incurred by the Lessee in connection therewith to be considered as part of the costs referred to
