POWER OF ATTORNEY

The property to be conveyed under this Power of Attorney is as follows:

BEGINNING at an iron pin on the Eastern edge of the right of way for Pleasantburg Drive (U.S. Highway No. 291) at the Northwestern corner of the premises herein described and at the joint corner with property now or formerly of D. Vandiver, Jr., and running thence with the line of the said Vandiver property N. 83-35 E. 175 feet to an iron pin; thence with the line of property now or formerly of David Wallace S. 5-19 E. 125 feet to a point; thence a new line through the original tract and with the line of property now or formerly of Vincent J. Perone S. 83-35 W. 173.6 feet to a point on the Eastern edge of the right of way for Pleasantburg Drive; thence with the Eastern edge of said right of way for Pleasantburg Drive W. 6-41 W. 25 feet to an iron pin; thence continuing with the Eastern edge of said right of way for Pleasantburg Drive N. 5-45 W. 100 Feet to the point of beginning.
