WITNESSETH:

For and in consideration of the sales price and mutual covenants herein contained, the Seller does hereby agree to sell unto the Buyer, and the Buyer does hereby agree to buy, the following described real estate, to wit:

All that piece, parcel or tract of land situated, lying and being in the County of Greenville, State of South Carolina as shown on a plat prepared by T. H. Walker, Jr. R. L. S. #3182 and having the following metes and bounds to wit: 4.0 acres

Beginning at an iron pin and running 388-51E, 787.13 tot. feet to an iron pin; thence running S10-40W, 40 feet to an iron pin; thence 39-08W, 169.6 feet to an iron pin; thence N88-58W, 777.4 tot. feet to an ir n pin; thence running N6-40E, 210 feet to the point of beginning, being in the center of new cut road and 2579 feet South of the paved county road.

- 1. Deed.
