REAL PROPERTY AGREEMENT

Beginning at an iron pin on the eastern side of Mayflower Avenue at the joint front corner of Lots Nos. 5 and 6 and running thence S. 72-27 E. 150 feet to an iron pin joint rear corner of said Lots: thence S. 17-33 W. 70 feet to an iron pin joint rear corner of said running thence along the joint line of said lots N. 72-27 W. 150 feet to an iron pin on the eastern side of Mayflower Avenue joint front dorner of Lots Nos. 6 and 7; thence along the eastern side of said Avenue N. 17-33 E. 70 feet to the point of beginning.
