In consideration of such Icans and Indebtedness as shall be made by or become due to The Palmetto Bank to as "Bank") to or from the undersigned, jointly or severally, and until all of such hans and indebtedness have been raid in full, or until taenty-one years following the death of the last survivor of the undersigned, whichever first occurs, the undersigned, jointly and severally, promise and agree

- 1. To pay, prior to becoming delinquent, all taxes, assessments, dues and charges of every kind imposed or levied upon the real property described
- 1. Without the prior written consent of Bank, to refrain from creating or permitting any lien or other encumbrance (other than those presently existing) to exist on, and from transferring, selling, assigning or in any manner disposing of, the real property described below, or any interest therein; or any leases, rents or funds keld under escrow agreement relating to said premises; and
 - 1. The property referred to by this agreement is described as follows:

All that certain piece, parcel or lot of land in Greenville County, South Carolina, in Austin Township, being in the Town of Simpsonville on the South side of Trade Street, and containing 1/5 of an acre, more or less, bounded on the North by said Trade Street, on the East by lands, now or formerly, of F. M. Todd and on the South and West by Woodside Cotton Mills. The lot extends from Trade Street back to the lot of land sold by Russell E. Thackston to Woodside Cotton Mill Co., recorded in Deed Volume 328 at page 263. Upon payment of all indebtedness of the undersigned to Bank this agreement shall be and become void and of no effect, and until then it shall apply to and hind the undersigned, their heirs, legattes, devisees, administrators executors, successors and assigns, and irure to the benefit of Bank and its successors and assigns. The affidavit of any officer or department manager of Bank showing any part of said indebtedness to remain unpaid shall be and constitute conclusive evidence of the validity, effectiveness and containing force of this agreement and any person may and is hereby authorized to rely thereon.
