Without the prior written consent of Bank, to refrain from creating or permitting any lien or other encumbrance (other than those presently existing) to exist on, and from transferring, selling, assigning or in any manner disposing of, the real property described below, or any interest therein; or any leases, rents or funds held under escrow agreement relating to said premises; and

The property referred to by this agreement is described as follows: County of Greenville, being shown and designated as Lot 145 and part of Lot 144 on Plat of Lake Forest Subdivision, Section 3, said Plat being recorded in the RMC Office for Greenville County in Plat Book GG at Page 77, and having, according to said Plat, the following metes and bounds, to-wit: BEginning at an iron pin on the Bastern side of Rockmont Road at the joint front corner of Lots 145 and 146 and running thence with the line of Lot 146, N. 84-36 E. 181.21 feet ot an iron pin; thence S. 2-06W. 143 feet to an iron pin; thence S. 86-39 W. 157-1 feet to an iron pin on Rockmont Road; thence along Rockmont Rd. That if default be made in the performance of any of the terms hereof, or if any of said rental or other sums be not paid to Bank when due, Bank, at its election, may declare the entire remaining unpaid principal and interest of any obligation or indebtedness then remaining unpaid to Bank to be due and payable forthwith.
- 5. That Bank may and is hereby authorized and permitted to cause this instrument to be recorded at such time and in such places as Bank, in its discretion, may elect.
- Upon payment of all indebtedness of the undersigned to Bank this agreement shall be and become void and of no effect, and until then it shall apply to and bind the undersigned, their heirs, legatees, devisees, administrators, executors, successors and assigns, and inure to the benefit of Bank and its successors and assigns. The affidavit of any officer or department manager of Bank showing any part of said indebtedness to remain unpaid shall be and constitute conclusive evidence of the validity, effectiveness and continuing force of this agreement and any person may and is hereby authorized to rely thereon.
