KNOW ALL MEN BY THESE PRESENTS, that I, Jerri Anne S. Mostella,

in consideration of Three Thousand and No/100 (\$3,000.00) Dollars,

the receipt of which is hereby acknowledged, have granted, bargained, sold, and released, and by these presents do grant, bargain, sell and release unto Jerry O. Sims, his heirs and assigns forever:

ALL MY ONE-SIXTH INTEREST IN AND TO:

ALL that lot of land in the County of Greenville, State of South Carolina, in the vicinity of Fountain Inn, S. C., containing 0.6 acres, more or less, as shown on plat of Jerry Sims property recorded in Plat Book "ZZ", at page 67, and having according to said plat, the following metes and bounds, to-wit:

BEGINNING at an iron pin in the center of a small unnamed road, which small road runs off of the southern side of Goldsmith Road at a point approximately 500 feet southwest of the intersection of Goldsmith Road and Jones Mill Road, which point is 598 feet from the middle of Goldsmith Road, and running thence S. 64-30 E. 175 feet to an iron pin; thence S. 25-30 W. 150 feet to an iron pin; thence N. 64-30 W. 175 feet to an iron pin in the center of said road; thence with the center of said road N. 25-30 E. 150 feet to the point of beginning and being a portion of the property conveyed to William S. Sims in Deed Book 230, at Page 245.

ALSO: ALL that certain lot of land situated in Fairview Township, County of Greenville, State of South Carolina, fronting on Fountain Inn Drive and being more fully described, to-wit:

BEGINNING at an iron pin in the center of Fountain Inn Drive, joint front corner with proper presently owned by Grantor and running thence along Grantor's property line S. 64-30 E. 175 feet to iron pin; thence S. 25-30 W. 200 feet to iron pin; thence N. 64-30 W. 175 feet to iron pin in the center of said road; thence with the center of said Road N. 25-30 E. 200 feet to an iron pin, being the point of beginning.
