All my right, title and interest, the same being an undivided one-half  
interest in and to the following described property:

All that piece, parcel or lot of land, with all improvements thereon,  
situate, lying and being in the State of South Carolina, County of  
Greenville, on the eastern side of Orchard Drive, being shown and designated  
as Lot No. 171 on a plat entitled SECTION 3, ORCHARD ACRES, made by J. Mac  
richardson dated May, 1960, recorded in the RYC Office for Greenville County  
South Carolina in Plat Book QQ at page 143 and having according to said  
plat the following metes and bounds, to-wit:
