ALL that certain piece, parcel or lot of land lying, being and situate in the State and County aforesaid and being shown on a plat of property of William Ray and Barbara S. Brown, prepared by J.L. Montgomery III, RLS, in March, 1977, which plat is recorded in the RMC Office of Greenville County in plat book 8-1 at page 11 which property is better described in accordance with said plat as follows:
