the receipt of which is hereby acknowledged, have granted, bargained, sold, and released, and by these presents do grant, bargain, sell and release unto

Ronald Calhoun and his heirs and assigns forever,

ALL that parcel or lot of land in Oneal Township or Greenville County, S.C., about three miles north of the City of Greer, lying on the east side of Motherwell Drive, being shown as LOT NO. 33 on a plat of a subdivision known as HOLLIDAY HILL, prepared by John A.
