FURTHER, unless sooner revoked or terminated by me, this Special Power of Attorney shall become null and void from and after 24 Jan 81

Notwithstanding my insertion of a specific expiration date herein, if on the above specified expiration date I shall not have been, or am in a military status of "missing," "missing-in-action" or "presumed-dead," then this power of attorney shall automatically continue to remain valid and in full effect until my (the day after I have returned to United States) military control following termination of such "missing," "missing-in-action" or "presumed-dead" status.
