I. Pipe; 25 feet, more or less of 6" D. I. Pipe; 1 8" Valves; 2 6" Valves; 1 2" Valve; and 2 Fire Hydrants and is shown on a drawing entitled "George L. Coleman, Jr. to Commissioners of Public Works of the City of Greenville, S.C." dated February 4, 1981, attached hereto and made a part of this conveyance.
