KNOW ALL MEN BY THESE PRESENTS, that (formerly Katharine Bush Edwards), individually and as Executrix of the estate of Thomas W. Edwards, deceased (hereinafter referred to as Grantor)

the receipt of which is hereby acknowledged, have granted, bargained, sold, and released, and by these presents do grant, bargain, sell and release unto THOMAS W. EDWARDS, JR. (hereinafter referred to as Grantee), his heirs and assigns forever, (1) an undivided ONE TENTH (1/10) interest in and to the herein described property and (2) a remainder interest in and to the remaining NINE TENTHS (9/10) interest in and to the herein described property, subject only to the Grantor's right to convey by sale all or any part of the NINE TENTHS interest, in fee simple provided the interest is sold to a purchaser who pays the current fair market value for the real estate conveyed. Grantor agrees that any liens or encumbrances on the property which she has created or which arise during her lifetime or as of her death will be paid by her estate. Upon the death of Katharine Bush Edwards Wyman any and all of the remaining unsold portion of the 9/10 undivided interest described above in the herein described property will be solely owned by Thomas W.
