... to the undersigned in hand paid by the City of Greenville, S. C., the receipt whereof being hereby acknowledged, (1) (we) hereby grant unto said City of Greenville, a right-of-way or easement along, over or under (my) (our) property for the purpose of:

Constructing the Werwood Trunk Sewer (being 12", 15" and 16" diameter) beginning at the existing Western Carolina Regional Sever Authority 30" sanitary sever trunk line near Laurel Creek approximately 1200 feet northeasterly of Mauldin Road then extending northerly across Laurel Creek and Ridge Road along a Laurel Creek Tributary for a distance of approximately 9,565 feet to a point immediately north of Fairforest Way.

Be it further agreed and understood that:

- 1. A 25' temporary construction easement on each side of the centerline of the sanitary sewer trunk line is herein granted, and this in no way will grant an additional permanent easement.
- No access to the easement across the 23.75 acre parcel herein later described will be allowed for any construction operation involved with the said sanitary sewer trunk line.
- Clearing of trees will only be allowed within the 25' permanent easement. All cleared trees shall be removed completely from the site, including the stumps.
- The entire construction area that is disturbed shall be regraded to the original contour and stabilized with seed and mulch.
- 5. An 8 inch diameter, plugged stub, pointing in a Westerly direction shall be installed in Manhole No. 41.
