DESCRIPTION

No. 1: All that parcel of land located in the State and County aforesaid and having the following courses and distances, to wit: Beginning at a point in the western property line of Mary Elnora Hart Parker, the northeastern corner of the property of Willie Albert Hart and running thence along the eastern line of Hart S 10 W 25 feet to a point; thence S 85-15 E 25 feet to a point; thence N 45-00 E 60 feet more or less to a point in a line 25 feet south of the northern property line of Mary Elnora Hart Parker; thence S 85-15 E 360 feet more or less to a point; thence N 10 E 25 feet to a point in northern property line of Mary Elnora Hart Parker; thence along the northern property line of Mary Elnora Hart Parker N 85-15 W 350 feet more or less to the western property line of Mary Elnora Hart Parker; thence with the western property line of Mary Elnora Hart Parker S 10 W 80 feet more or less to the beginning point.

No. 2: All that parcel of land located in the State and County aforesaid and having the following courses and distances, to wit: Beginning at a point in the southern property line of Mary Elnora Hart Parker, this point being located 186.5 feet east of the southwest corner of the property of Mary Elnora Hart Parker, and running thence along the southern property line of Parker S 85-15 E 50 feet to a point; thence N 10 E 183.8 feet to the northern property line of Mary Elnora Hart Parker; thence with the northern property line of Parker N 85-15 W 50 feet to a point; thence S 10 W 183.8 feet to the southern property line of Parker at the beginning point.
