(17) Declarant reserves the right to waive any or all of these restrictive covenants from any single lot or tract being 15 acres or more. Such a waiver must be in writing at the time of the sale and accompany the instrument of convenance.

These restrictions and covenants are to run with the land and shall be binding on all parties and persons claiming under them for a period of ten (10) years from the date these restrictions are recorded, after which time said covenants shall be authomatically extended for successive periods of ten (10) years each unless an instrument signed by the owners of 2/3 majority of the tracts has been recorded agreeing to change said restrictions in whole or in part.

Enforcement shall be by proceedings at law or in equity against any person or persons violation or attempting to violate any covenant either to restrain violation or recover damages.

Invalidation of any of these covenants or restrictions by judgement or court order shall in no way effect any other provision which shall remain in full force and effect nor shall failure by Seller or any other person to enforce any measure or provision, upon violation thereof stop or prevent enforcement
