## DESCRIPTION OF LEASED LAND

EEGINNING at a point on the southern side of the right of way of the Seaboard Coastline Railroad located N. 71-50 W. 374.93 feet from an iron pin at the intersection of said right of way and the line dividing property of Greenville County and property now or formerly of T. W. BEGINNING at a point located S. 6-33 E. 33.03 feet from the southern side of the right-of-way of the Seaboard Coastline Railroad; thence running S. 71-50 E. 58.85 feet to a point; thence running S. 18-10 W. 10.0 feet to a point; thence turning and running N. 71-50 W. 54.26 feet; thence N. 6-33 W. 11.0 feet to the point of beginning, being a portion of the property acquired by Greenville County by deed of Hart Graphics, Inc. dated as of May 1, 1980 and recorded May 27, 1980 in the R.M.C. Office for Greenville County in Deed Book 1126 at Page 375.
