Dear Mrs. Wood:

over the last several days Richard Kelly and I have conversed with you regarding the financial situation existing at the Days Inn in Greenville, South Carolina. You had requested this law firm to represent you in unraveling the legal quagmire that has existed since Ray's Motel Corporation and Bear Country Corporation have operated the motel. We advised you that this law firm represents Triangle Construction Company which had filed a lien against the motel property in February. As a result of our representation of Triangle, there exists a conflict of interest which has to be resolved before we can undertake the representation of your husband should such representation be desired in the future.

In my discussion with you on March 8, 1982 you advised that you are not requesting this law firm to undertake the representation of your husband at the present time because you intended to use your attorney in Great Falls, Montana. Therefore, unless we are requested to represent your husband in the future, we will take no further action with regard to resolution of the conflict of interest problem for the legal problems with which the Days Inn is faced.
