authority as is conferred herein to be exercisable during any such physical disability or mental incompetence suffered by me. In the event of any such disability or mental incompetence suffered by me, all acts done by the attorney above appointed shall have the same effect and inure to the benefit of and bind me, my heirs, devises, legatees and personal representatives.

Further, in the event of my disability or mental incompetence, my attorney-in-fact shall have a fiduciary relationship with me and shall be accountable and responsible to me as a fiduciary. I direct that my attorney-in-fact not be required to file with the Probate Court an inventory of all deposits, choses in action and personal property, nor shall such attorney-in-fact be required to post a surety bond with the Probate Court, as might otherwise be required by law.
