

KNOW ALL MEN BY THESE PRESENTS, That I, William F. Leineweber

to me----- in hand paid at and before the sealing of these presents by C. F. Haynsworth, Jr., Minor H. Mickel Shaw, George McDougall, Wade H. Dennis, Christie Prevost and W. Francis Marion -----

(the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents

dogrant, bargain, sell and release unto the said C. F. Haynsworth, Jr., Minor H. Mickel Shaw, George McDougall, Vade H. Dennis, Christie Prevost, and W. Francis Marion, their heirs and assigns, all my right, title and interest, the same being a one-seventh (1/7th) interest, in and to:

ALL that piece, parcel or lot of land situate, lying and being on the Southern side of Lowndes Hill Road in the City of Greenville, County of Greenville, State of South Carolina, and being known and designated as the greater portion of the property shown on a plat prepared by Piedmont Engineering Service, dated February 12, 1962, entitled "Property of Carolina Vend-A-Matic Company", recorded in the R.M.C. Office for Greenville County. South Carolina, in Plat Book AAA at page 3, and having according to said plat the following metes and bounds: 15 (500) 282-2-3.1

BEGINIING at an iron pin on the Southern side of Lowndes Lill Road, which iron pin is located 382 feet in a Southeasterly direction from the intersection of Lowndes Hill Road and Watson Road and running thence with the Southern edge of the right of way for Lowndes Hill Road S. 85-37 E. 483.4 feet to an iron pin; thence S. 2-23 W., 309.1 feet to an iron pin on the Northern side of Watson Road; thence with the Northern edge of the right of way for Matson Road; thence with the Northern edge of the right of way for Matson Road; 65-09 W., 526.4 feet to an iron pin; thence a new line with the line of property now or formerly of Harriett P. Bryant, C. F. Haynsworth, Jr., W. Francis Marion and Christie Prevost, N. 5-22 E., 138.7 feet to the point of beginning.
