ASSIGNMENT OF LESSOR'S INTEREST IN LEASE

together with any extensions of any thereof and any guarantees of the lessee's obligations under any thereof (each of said Leases, together with all such guarantees, modifications and extensions, being hereinafter referred to as "the Lease").

THE ASSIGNEE AGREES that:

- A. So long as there shall exist no default by the Assignor in the payment of any indeletedness secured here? or in the performance of any obligation of the Assignor herein or in the Mortgage or any other instrument security said indebtedness, the Assignor shall have the right to collect, but not more than 30 days prior to accrual, all remin issues and profits from the premises and to retain, use and enjoy the same.
- B. Upon the payment in full of all indebtedness secured hereby, as evidenced by the recording or filing of an instrument of satisfaction or full release of the Mortgage without the recording of another Mortgage in favor of the Assignee affecting the premises, this Assignment shall become and be void and of no effect.

THE ASSIGNOR AGREES, JOINTLY AND SEVERALLY IF THERE BE MORE THAN ONE ASSIGNOR, WITH RESPECT TO EACH LEASE that:

- 1. The Assigner will: fulfill or perform each and every condition and covenant of the Lease by Lessor to a fulfilled or performed; give prompt notice to the Assignce of any notice of default by the Assigner under the Lease received by the Assignor together with a complete copy of any such notice; at the sile cost and expense of the Assignor, enforce, short of termination of the Lease, the performance or observance of each and every covenant and condition of the Lease by the Lessee to be performed or of served; not modify nor in any way after the terms of the Lease; not terminate the term of the Lease nor accept a surrecolor there i wiless required to do so by the terms of the Lease; not anticipate the rer ts thereunder for more than 30 days prior to accound; and not waive nor release the Lessee from any obligations or conditions by the Lessee to be performed.
- 2. The rights assigned here inder include all the Assignor's right and power to nothly the Lease or to terminate of elternior to assert a surrei der thereof or to waive, or release the Lessee from the perfettion of the release by the Lessee of any obligation or condition thereof or to anticipate rents thereunder for more than 30 days prior to account.
- 3. At the Assignor's side cost and expense, the Assignor will appear in and defend any action growing out of or in any manner connected with the Lease or the obligations or liabilities of the Lessor, Lessee or any SATISFACTION CORDED MAR 7 1985 guaranter thereunder.
