ALL that certain parcel or lot of land located, situate and being in the State of South Carolina, County of Greenville, in the City of Greer, on the east side of Morrow Street, being known and designated as LOT NO. 6 and a PORTION OF LOT NO. 6, on a plat of property entitled "Brookville", recorded in Plat Book C, page 52, RMC Office for Greenville County, and having the following metes and bounds:
