Highway No. 11, containing 5.5 acres, more or less, and being shown and designated as Tract No. 9 on a survey for Harold Smith, dated March 2, 1973, by W. N. Willis, Engineers, and recorded in Plat Book 4-0 at Pages 71-74, R. M. C. Office for Greenville County and having, according to said plat, the following metes and bounds, to-wit:

BEGINNING at a point in center of an unpaved road, said point being 886 feet from the center of the intersection of said unpaved road and a county road known as Lee Road (iron pin back at 30 feet), and running thence South 64 degrees 30 minutes East 485 feet to an iron pin; thence North 35 degrees 00 minutes East 554 feet to an iron pin; thence North 75 degrees 30 minutes West 541 feet to a point in center of unpaved road; thence with center of said road South 21 degrees 30 minutes West 240 feet; thence South 32 degrees 00 minutes West 100 feet; thence South 43 degrees 00 minutes West 120 feet to the point of BEGINNING.
