PARCEL 1: ALL that certain piece, parcel or lot of land with the buildings and improvements thereon lying and being on the northwesterly side of Wade Hampton Boulevard, in the City of Greenville, South Carolina, and being shown as a 0.92 acre-tract on survey entitled "Property of Lewis C. Barker and Charles F. Sims" dated December 6, 1983, made by R. B. Bruce being recorded in Plat Book 105, at page 28, and having, according to said plat, the following metes and bounds, to-wit 13 500 - 188.
