attorney's fees, in connection with defending such claim.

In the event of any dispute between the Grantor—and the Grantee arising out of the terms and conditions of this Timber. Deed and the performance of other parties thereunder, Grantor—and Grantee agree s—to accept and be bound by the decision of an arbitration board of three (3) members, with one member being selected by the Grantor—, one by the Grantee and the third member being selected by the first and second arbiters appointed. The arbiters appointed must reach an agreement within thirty (30) days after the appointment of the arbiter by the Grantor—and the Grantee. The parties agree to abide by and to be controlled by the "Uniform Arbitration Act" as enacted in South Carolina. The period allowed herein for cutting and removal of timber shall be extended automatically for the number of days required to complete the selection of the arbiters and to complete the arbitration of such issues.

Neither Grantor nor Grantee shall be responsible for non-performance due to strike, lockout, riot, war, civil disturbance, Act of God or other causes (whether or not of a similar nature) beyond the reasonable control of the parties. At the option of the Grantee, the terms of this contract shall be extended for a period of time equal to the time the Grantee is prevented from cutting and removing said timber due to any of the above occurrences so that the Grantee shall have sufficient time to

remove said timber.

TO HAVE AND TO HOLD, all of the timber herein conveyed, to the extent cut and removed within the time herein stated, to the said Georgia-Pacific Corporation, its successors and assigns, forever.

And the Grantor do es hereby warrant and defend title to the said property herein conveyed unto the said Georgia-Pacific Corporation, its successors and assigns forever from and against any and all rights or claims of any and all persons, firms and corporations whatsoever.
