my benefit, provided that in the opinion of two or more physicians licensed to practice in South Carolina, based upon ordinary standards of medical practice, given in writing to Attorney:

- (i) I have undergone an irreversible cessation of total spontaneous brain function, or
- (ii) I have lost consciousness for a period of thirty days and my condition is terminal, irreversible, or there is no reasonable medical expection of recovery.

In such event or events, Attorney is further authorized:

- (a) In Attorney's sole discretion, to petition any court of competent jurisdiction for a mandatory injunction regarding compliance by hospital staff, doctors, nurses or any other medical personnel with the actions taken by Attorney authorized under this special power of attorney.
- (b) In Attorney's sole discretion, prior to taking any of the actions authorized hereunder, to seek on my behalf and at my expense a declaratory judgment from any court of competent jurisdiction interpreting the validity of any or all acts authorized by this special power of attorney, but such declaratory judgment shall not be necessary in order for Attorney to perform any act authorized hereunder.
- name, on my behalf and at my expense to bring an action against any hospital staff, physician, nurse or other medical personnel who fail to comply with actions taken by Attorney under this special power of attorny and to demand damages of all kinds, including actual and punitive damages.

## 2. Power Not Affected by Principal's Incapacity

This power of attorney shall not be affected by physical disability or mental incompetence of the Principal which renders the Principal incapable of managing his own estate. It is my intent that the authority conferred herein shall be exercisable notwithstanding my physical disability or mental incompetence.
