PROPERTY DESCRIPTION

C., in Plat Book "V", at page 115, and running thence along line of property of the Grantees herein, N. 86-23 E. 122.5 feet to an iron pin; thence continuing along line of property of the Grantees N. 0-33 W. 54.2 feet to an iron pin; thence N. 89-59 E. 10 feet to an iron pin; thence S. 0-01 E. 200 feet to an iron pin; thence S. 89-59 W. 32.3 feet to an iron pin at corner of property of E. M. Bishop; thence along said Bishop line N. 0-01 W. 60 feet to an iron pin; thence continuing along the said Bishop line S. 87-17 W. 100 feet to an iron pin on the East side of the Augusta Road; thence along the East side of Augusta Road N. 0-01 W. 82.9 feet to the beginning corner. BECINNING at an iron pin at the Northeast corner of property now belonging to the grantee herein and running thence along line of other property of the grantor, S. 70-02 E., 124.6 feet to an iron pin; thence S.17-06 W. 142.8 feet to an iron pin; thence along line of property now or formerly of Baldwin, S. 88-50 W., 71.3 feet to an iron pin in the East line of property of the grantee; thence along line of property of grantee, N. 1-10 W., 180 feet to the beginning corner.

TOGETHER with an easement for ingress and egress for the use of the grantee, his heirs and assigns, to be used in common with any other person who may be granted a like right in, over and along the following described strip of land leading from the Southeast corner of the above described lot in a Southerly direction to Lydia Street:

Carrere, said pin also being 114.7 feet East from the Northeast corner of the intersection of Lydia Street and Augusta Road and runs thence N. 3-17 W., 135.4 feet to an iron pin; thence S. 86-08 W., 5 feet to an iron pin; thence N.1-10 W., 50 feet to an iron pin; thence S. 88-22 E., 32 feet to an iron pin; thence S. 1-38 W., 20 feet to an iron pin; thence N. 88-22 W., 16.26 feet to an iron pin; thence S. 3-17 E., 161.79 feet to an iron pin on the North side of Lydia Street; thence along Lydia Street S. 72-30 W., 12.38 feet to the beginning corner.
