ALL THAT PIECE, parcel or lot of land, containing 0.2 acres, more or less, and being shown as a portion of the property on a plat entitled "Survey for J. David Turner" prepared by Williams & Plumblee, Inc., Engineering and Land Surveying Company, dated November 30, 1981, and recorded in the R.M.C. Office of Greenville County in Plat Book 9A, at Page 63, and having according to said plat the following metes and bounds, to wit:

Beginning at a point on the common line of the Grantee and property now or formerly of Batson, said point being 456.0 feet, more or less, from the sourthern side of Little Texas Road in Greenville County as shown on said plat, and thence running along the common line of Batson and the Grantee S 20-32 W 73.0 feet to a iron pin on the existing right-of-way of Commissioners of Public Works of the City of Greenville, S.C.; thence along said right-of-way S 63-46 W 164.3 feet to an iron pin at the corner of property, now or formerly, of Brantley; thence N 3-26 W 54.2 feet to an iron pin; thence N 63-46 E 196.5 feet to an iron pin, the beginning point.
