IN THE COURT OF COMMON PLEAS

To All Whom These Presents Shall Come:

I, W. Daniel Yarborough, Jr., as Master in and for the County aforesaid, SEND GREETING:

WHEREAS, Paul Anthony Campbell

on or about the 22nd day of October in the year of
our Lord nineteen hundred and eighty-two exhibited his
complaint in the Court of Common Pleas for the County aforesaid, against
Donald Durant Campbell, Jr., William Howard Campbell, James Pearson Campbell,
John Gregory Campbell, Thomas Edward Campbell and George Christopher Campbell
demanding relief as to the real estate described in the complaint: and the cause being at issue, came on to be heard
on the 22nd day of September 19 83,
and such proceedings were had therein as resulted in a decree of the said Court, whereby it was adjudged and
decreed that the said real estate hereinafter mentioned and described, be conveyed by W. Daniel Yarborough, Jr.

NOW, Therefore, Know all Men by these Presents, that I, W. Daniel Yarborough, Jr., as Master, in and
for the County of Greenville aforesaid, by virtue of the aforesaid decree,

HAVE GRANTED, conveyed and released, and by these presents, DO GRANT, convey and release unto
the said George Christopher Campbell:

ALL of that certain piece, parcel or lot of land situate, lying and being
in Greenville County, South Carolina on Adams Mill Road, being a portion
of property shown on plat of property of the Estate of Donald C. Campbell,
dated April 20, 1981, be Clelland A. Tyson, and having according to said
plat the following metes and bounds, to-wit:

BEGINNING at an I.P.S. on joint property line now or formerly of Roberts
and joint line of Thomas Edward Campbell and running with the common line
of Thomas Edward Campbell in a south easterly direction 438 feet to a
point at the joint corners of Thomas Edward Campbell and William Howard
Campbell and running thence in a westerly direction with the common line
of William Howard Campbell 465 feet to a point; thence N. 00-05 E. 560 feet
