the receipt of which is hereby acknowledged, have granted, bargained, sold, and released, and by these presents do grant, bargain, sell and release unto



W. H. DRESBACK AND LEE V. DRESBACK, THEIR HEIRS AND ASSIGNS FOREVER:

ALL that certain piece, parcel or tract of land in the State of South Carolina, County of Greenville, near Tigerville on Pack Mountain Ridge Road, being shown as 3.5 acres on plat entitled "Survey for W. H. Dresback" prepared by W. R. Williams, Jr. Surveyor, and having, according to said plat, the following metes and bounds, to wit:

BEGINNING at a point in the centerline of Pack Mountain Ridge Road (which point is 1090 feet west of Ponder Lane) thence S.70-59W., 195 feet to a point in centerline of said road; thence adjoining the James property N.11-02W., 315.2 feet to an iron pin; thence S.62-32W., 192.0 feet to an iron pin; thence N.8-24W., 270.0 feet to an iron pin; thence N.72-12E., 375.0 feet to an iron pin; thence S.10-15E., 547.8 feet to a point in the centerline of Pack Mountain Ridge Road being the point of beginning.
