the receipt of which is hereby acknowledged, have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto Edna R. Foster, her heirs and assigns in fee simple forever the following:

All that piece, parcel and tract of land located in Greenville County approximately eight miles north of Travelers Rest, South Carolina, in Saluda Township, approximately 295 feet northeast from the center line of Goodwin Bridge Road, containing 1.51 acres and being more particularly described as follows:

Beginning at an iron pin located in the northeastern corner of the Johnny H. McKenzie tract of land which is described in Deed recorded in Book 1154 at page 866 in the RMC Office of Greenville County; the iron pin at the beginning point is located N.72-14E. 295.0 feet from an iron pin located in the center of Goodwin Bridge Road (Highway 130) directly in front of Golden Grove Church and approximately 1/4 mile north of the intersection of Goodwin Bridge Road and Golden Grove Road; beginning at the iron pin in the northeastern corner of the Johnny H. McKenzie tract, in the Deed referenced herein and running N.72-14E. 143.6 feet to an iron pin; thence N.50-56E. 80.0 feet to an iron pin thence with the H. W. McKenzie line S.05-17E. 334.4 feet to an iron pin; thence S.72-17W. 226.2 feet to an iron pin which iron pin also designates the southeastern corner of the Johnny H. McKenzie tract as described in Deed referenced herein; thence with the eastern border of the Johnny H. McKenzie tract N.02-39W. 308.2 feet to an iron pin, the point of beginning containing 1.51 acres more or less.
