KNOW ALL MEN BY THESE PRESENTS, that I, FRED SMITH

In consideration of Two Thousand Five Hundred and No/100 Dollars,

the receipt of which is hereby acknowledged, have granted, bargained, sold, and released, and by these presents do grant, bargain, sell and release unto NANCY JANE EARL, her heirs and assigns forever,

All that certain piece, parcel or lot of land situate, lying and being in the State of South Carolina, County of Greenville, near the town of Simpsonville, off Charlie Black Road, and being more particularly described according to a plat entitled "Survey for William Steve Smith" prepared by Carolina Surveying Company, dated November 20, 1978, which plat is recorded in the RMC Office for Greenville County, South Carolina in Plat Book 7-H, at Page 43, and having, according to said plat, the following metes and bounds, to-wit:

BEGINNING at an iron pin on Benny Road, which pin is approximately 1,060.5 feet from the intersection of Benny Road and Charlie Black Road, and running thence S. 18-50 E. 135 feet to an iron pin; thence S. 68-00 W. 621.3 feet to an iron pin; thence N. 9-09 E. 195 feet to an iron pin; thence N. 71-29 E. 528.8 feet to an iron pin, the point of beginning, and containing two (2) acres more or less.

This is the same property conveyed to Fred Smith by deed of Melvin Coker, dated April 7, 1983, recorded in the office of RMC for Greenville County, S.C. in Deed Book 1186, page 448, on April 15, 1983.

The grantee is hereby granted a 30 foot appurtenant easement across the eastern property line being described as Benny Road.

This deed is made subject to any restrictions, easements, and rights of way that may appear of record and/or on the recorded plat and/or on the premises.
