Landreth and Carol J. Landreth, their heirs and assigns forever:

ALL that certain piece, parcel or lot of land situate, lying and being on the Northwest side of Perrin Street, City of Greenville, County and State aforesaid, and being the major portion of lot # 8 on plat of Property of Ed B. Smith, made by C.C. Jones, Engineers, in October, 1951, recorded in the RMC Office for Greenville County, S. C. in Plat Book FF at Page 62 and 63, and having according to a recent survey and plat entitled "Plan of Land for Francis Asbury Methodist Church" prepared by Robert H. Johnson, R.L.S., in June, 1984, the following metes and bounds, to-wit:
