Joseph A. Wells, his heirs and assigns, forever:


ALL that piece, parcel or lot of land, with all buildings and improvements,

original sum of \$39,500.00, recorded in Mortgage Book 1612, page 49 on
June 17, 1983, and which has an approximate balance due in the sum of
\$39,328.71.
