In consideration of the nutualStatuenants and agreements herein contained, it is agreed: Proprietor hereby grants sunto Company the exclusive right for five years to install and maintain coin operated music and amusement machines upon the premises located at 2935 WhiteHorse Rd. Greenville, S.C.

Corpany shall install upon said presises the following coin operated eachines: All coin operated nusic and amuschent nachines with monies being divided equally 50%Proprietor and 50% Company. All machine licenses and/or taxes shall be divided equally 50%/50% Proprietor and Company. In consideration therefore Company shall open the coin boxes of such rachines weekly and the excess in the contents thereof over \$1.00 shall be divided equally between Company and Proprietor. In any event, Company shall be entitled to a weekly minimum of \$100.00 per machine Draw Poker, \$50.00 minimum per machine video, and \$25.00 minimum per machine electronechanical games. In the event a machine does not generate the weekly minimum Company shall have the right to remove or replace said rachine. Proprietor shall furnish to Company all necessary electrical outlets for the operation of such machines. Proprietor shall use all best efforts to allow the operation of such vachines during all usual business hours without hindrance.

Company shall service such machines upon said premises and collect the contents of coin boxes of such machines with repair service between the hours of 9:00AM and 6:00 PM daily except there will be no Sunday service.

All machines installed by Company and all contents of coin boxes thereon shall remain the sole and exclusive property of Company and neither Proprietor nor any third party shall have any right of claim thereto except the right of Proprietor to share in the contents of the coin boxes as provided herein. All rachines so placed shall bear the name of Company and shall state thereon that said machines are the sole property of Company. During the full term and any continuation thereof, no other person, firm or corporation, including Proprietor, shall have the right to operate coin operated music or amusement machines upon said premises nor shall any other commercial amusement machine system be operated on said premises during said term or any continuation thereof. Proprietor warrants that machines are to be operated in a lawful manner at all times.

Following the terms thereof, this agreement shall automatically continue for an additional period of one year and from year to year thereafter until written notice of termination be received no less than sixty days prior to the end of any term hereof. Except as provided herein and except for a breach hereof, this agreement shall be irrevocable by the parties hereto.

In the event of any breach of the agreement, in addition to any other remedy which it may have in law or in equity, Company may elect to terminate this agreement and remove all such rachines without interference from Proprietor and shall be entitled to liquidated damages of a sum equal to the Company's average weekly share of the contents of the coin boxes prior to said breach multiplied by the number of weeks remaining in the unexpired term of this agreement.

I This agreement shall be binding upon the parties hereto, their heirs, executors, ad-(distrators, successors and assigns, and in the event Proprietor sells or assigns his interest in the said premises, such successor shall be fully found by the terms of this agreement. This agreement shall not be construed to create a joint venture between the parties hereto. In the event the business is leased or sold Collins Music Company has the first refusal.

Inothe event a Court of competent jurisdiction declare any of the conditions or terms hacin above listed imalid, it is understood and agreed by the parties hereto that the remaining conditions or terms shall have the full force and effect.

This centains all the agreements of the parties, there being no other reservations or understandings. Parties certify authority to enter into this agree ent.

Figrietor certifies that he/she is not a party to or has a covenant with or restriced to any other coin machine agreement.
