AN UNDIVIDED ONE-HALF INTEREST IN AND TO THE FOLLOWING DESCRIBED PROPERTY:

All that certain piece, parcel or lot of land in the State of South Carolina, County of Greenville, situate, lying and being on the eastern side of Montverde Drive, being known and designated as Lot No. 9 on plat of Montverde Subdivision, Section 2, as recorded in the RMC Office for Greenville County, South Carolina, in Plat Book KK at Page 103, and having, according to said plat, the following metes and bounds, to-wit:
