BEGINNING at said intersection of Main Street and Hillcrest Drive and running thence along said Main Street, N. 14-46 E., 192.2 feet to a 15 foot alley; thence N. 66-30 W. along the south side of said alley, 56 feet; thence S. 23-30 W., 190 feet to a point on Hillcrest Drive, 85 feet from the beginning corner; thence, along the north side of Hillcrest Drive, S. 66-30 E., 85 feet to the beginning corner.

The above described land is composed of a part of Lot No. 1, Block F, Highland Terrace, as shown by plat recorded in Plat Book E at Page 102 and a 10 foot strip off of the eastern side of Lot No. 2, as shown on said plat and for courses and distances of the lot herein conveyed, see revised plat recorded in Plat Book F.
